20 Members Present

1. Directors held a meeting at 6:00 PM at Gerald Wrights garage to fill the Vice Presidents position and to discuss the misunderstanding of sponsorship money.
2. Bill Wright made a motion to to put Don Trelease in as Vice President, second by Robbie Anderson all in favor yes.
3. Meeting at the Hamden Town Hall opened to the Pledge of Allegiance at 7:12 PM.
4. Last months minutes read by Don Bender.
5. Treasures report read by Lauren Fletcher motion to accept financial report by Gerald Wright,second by Steve Reed.
6. Grass seed that was purchased last month has been put down on the East Brook bridge (C2A) but the Ramp and where work was done at the College still has to be seeded.
7. Voting Don Trelease in as VP leaves a directors position opened. A new director will be voted in at a future meeting. Anybody interested in the position is to contact Don Bender.
8. Water Race discussion about what was discussed at last meeting. It was discussed as a club at our last meeting not to pay the racers. The racers were to get in for free and we would not give money back to racers this year but possibly at future races.
9. Discussion on how to handle the money from sponsors. Steve Reed made a motion not to send a letter or check just let the whole situation dissolve itself. 14. Gary Tymeson submitted a bill for \$1500.00 to pay the racers. Hank Groth made a motion not to pay the racers, second by Joe Caso. Motion passed by majority not to pay.
15. Hank brought up that all members should make a proposal for any work they want done BEFORE doing the job. Also the club should not be paying for any posters contact Hank and he can get them done by a member for free.
16. Selling things at an event needs to be done under HHRR not outsiders we want the club to profit.
